During my prior government service, I was a Managing Director and Regional Head at the U.S. International Development Finance Corporation (DFC), where I worked to mobilize U.S.-led financing alternatives to counter China and Russia. I was also tasked with implementing the *Washington Agreements* brokered by President Trump between Kosovo and Serbia by coordinating an "all of government" economic engagement, including EXIM and DFC.

I have managed the successful development and construction of leading U.S. energy export projects, as well as the expansion of specialized manufacturing companies that produce vital tools and equipment, made in the USA, sold all around the world.

All throughout, I developed a keen understanding of how large and small businesses eager to expand their operations make the toughest of strategic decisions – especially the challenges they face in financing growth.
