Dear Director Pulte:

Our nation is in the midst of a housing crisis. As the Director of the Federal Housing Finance Agency (FHFA), you have a critical role to play in lowering housing costs for the American people. Yet since taking office, instead of prioritizing housing affordability, you have abused your power and authority as FHFA Director to engage in what can only be described as a politically motivated public campaign to attack President Trump's perceived adversaries.

Since your confirmation on March 13, 2025, you have accused New York Attorney General Letitia James, sitting U.S. Senator Adam Schiff, and Federal Reserve Governor Lisa Cook of mortgage fraud. Your attacks mirror those of President Trump, who has personally threatened all three officials with political and criminal retribution. And he is now engaged in a public effort—enabled by your mortgage fraud accusations—to illegally oust Governor Cook, a President Biden appointee, from the Federal Reserve after months of trying, and failing, to push the central bank to lower interest rates at his request.

Your most recent accusation against Governor Cook comes in the wake of your multi-week effort to push President Trump to illegally fire Federal Reserve Chair Jerome Powell and erode the independence of our nation's central bank.⁴ In addition to repeatedly criticizing Chair Powell on social media and reportedly drafting a termination letter for the President to send to Chair

Powell,⁵ you facilitated President Trump's unproven allegations that Chair Powell was responsible for mismanagement of the Federal Reserve's long-standing efforts to renovate its buildings.⁶ It is no coincidence that this push to fire Chair Powell came as the Federal Open Market Committee held interest rates steady despite President Trump's and your demands for cuts.

You have suggested that your focus on the unproven allegations of mortgage fraud against officials such as Attorney General James, Senator Schiff, and Governor Cook represents an apolitical effort to protect the housing market. But your statements and actions suggest it is instead a pattern of abuse of your power and authority as FHFA Director to help target and harass individuals perceived as political opponents of President Trump. Indeed, though you claim to have "criminally referred people of each political parties [sic.]" for mortgage fraud, the only officials you appear to have publicly and repeatedly accused are prominent Democrats.⁸ In one recent interview, when pressed on whether or not you planned to investigate the alleged mortgage fraud of Ken Paxton, a Republican and the Attorney General of Texas, you refused to comment. It is also unclear whether you have engaged in any effort to investigate Trump Administration cabinet members—Labor Secretary Lori Chavez-DeRemer, Transportation Secretary Sean Duffy, Environmental Protection Agency Administrator Lee Zeldin, and Treasury Secretary Scott Bessent—for alleged mortgage fraud after public reporting revealed that all may have engaged in activities similar to those you have accused Democratic officials of. 10 These actions raise questions about the standards your office is applying in determining which allegations to pursue and announce publicly.

To clarify our understanding of your use of public authority and resources to this effect, we request the following documents and information no later than October 10, 2025:

- 1. Provide copies of all email communications sent or received by you (on government and personal email accounts) since March 13, 2025, that include the following terms (whether in the subject line, body of the text, or relevant email attachments). Preserve all relevant records and documents.

 - b. "Letitia"

Provide a list of each individual or entity that FHFA has criminally referred for mortgage fraud since March 13, 2025. Preserve all relevant records and documents.
- 8. Provide copies of your official schedule in your capacity as FHFA Director for each business day since March 14, 2025. Preserve all relevant records and documents.
- 9. Provide copies of your official schedule in your capacity as Chair of the Board of Fannie Mae for each business day since March 17, 2025. Preserve all relevant records and documents.
- 10. Provide copies of your official schedule in your capacity as Chair of the Board of Freddie Mac for each business day since March 17, 2025. Preserve all relevant records and documents.
- 11. According to recent reporting, you are "in frequent communication with" Edward Martin, who has been designated as a "Special Attorney for Mortgage Fraud" at the Department of Justice. Martin, in turn, is "in frequent communication with" President Trump regarding mortgage fraud; meanwhile, "Trump is also understood to have lines of communication" open with you. 12 Please describe your relationship with Mr. Martin and

 - b. Please describe the role that the FHFA OIG plays in the FHFA's processes to identify, investigate, and criminally refer mortgage fraud.
 - c. Provide a list of all individuals employed at FHFA, Fannie Mae, and/or Freddie Mac who have access to information and documents (including but not limited to nonpublic information, sensitive personal information such as addresses and social security numbers, and financial information) regarding Enterprise-backed mortgages.
 - i. Have you personally or indirectly requested or received mortgage loan files or other documents or information, including related to mortgage fraud, from John Roscoe, Fannie Mae's Executive Vice President of Operations and Public Relations, or from his team?
 - d. Provide a list of all third-party entities, such as but not limited to Palantir, with the ability to access information and documents (including but not limited to nonpublic information, sensitive personal information such as addresses and social security numbers, and financial information) involving Enterprise-backed mortgages.
 - e. Provide a summary of the federal laws and regulations that govern the public and private use of mortgage documents, and the personal and financial information contained therein, by employees of FHFA, Fannie Mae, and Freddie Mac. Provide copies of, and preserve all relevant records and documents regarding, any internal FHFA, Fannie Mae, and Freddie Mac policies and procedures describing the applicability of these laws and regulations to mortgage fraud detection, prevention, investigation, and referral efforts, including any advice you may have received on these matters from agency Counsel or other officials.
 - f. Provide a copy of all internal policies and procedures that govern the public and private use of mortgage documents, and the personal and financial information contained therein, by employees of FHFA, Fannie Mae, and Freddie Mac. Provide copies of, and preserve all relevant records and documents regarding, any internal FHFA, Fannie Mae, and Freddie Mac policies and procedures describing the
